# **BVCCSC Executive Meeting Minutes**

- i) Racers-LM-Corner area of new wax hut will be used to store club waxes. Keys will be available to Racers, Biathlon and BD. Juvenile and Junior Racers have been invited to be forerunners for World Cup in Whistler.
- ii) Biathlon- JO. There will be a race in Quesnel in two weeks. 5 Master skiers are receiving instruction. More rifles are needed to accommodate more Master skiers.
- Rabbits-JC- 84 Rabbits registered with 3 on waitlist. An additional 15 track Attack skiers. Challenge is the number of coaches available. More coaches are needed to reduce group size. Recommend a training course for coaches at the end of the ski season to be better prepared for next ski season.
- iv) Masters-BD- Three instructors are available for Masters, and in the process of recruiting a few more coaches.
- v) Memberships-JK- 622 registered memberships. Ticket sales are way down compared to last year but need to check with Adrian J regarding deposits for ticket sales. In 2007, averaged \$116 per day; in 2008 it is \$46 per day. Drop box is in place at the lodge. BD is fixing up sandwich board to be placed at the beginning of lower parking lot: Ticket Checkers on trails today. Locker #1 is for ticket checkers (holds vest, sign in sheet). Will reassess at the end of ski season to determine if another booth will be constructed.

Area/Lodge/Community Forest -FO. First Aid stations have been checked by Jackie W-all have the required supplies. One more station to be set up on Pine Creek. Search procedures by phone have been updated. Water in lodge is now

good to drink. Regarding our Licence of Occupation, we still need to receive the Offer Letter from ILMB. It is a paper exercise and it should be obtained in a few months. Wax hut is fully wired.

To have the wax hut functional for this winter the decision has been made to install a wood heater rather than the planned electric heat. It has also been agreed that a combination of wood and electric heat will be more functional and save cost over the long-term. Electric heat will be installed next year. An option of a temporary wood stove (borrowed) has been considered. Given that the wood heater is intended to be permanent a better option is to install the permanent fixture now. Adrian has reviewed our finances and is comfortable (no pressure) with the cash flow.

**Be it moved** that a budget allocation of up to \$3,000 is available to purchase a wood heater and stove piping for the wax hut. The \$3000 allocation is in addition to the approved allocation of \$26,673. Carried 5/0

- Trail area and Maintenance \$5,500 (+500) Yes to increase.
- Ticket booth maintenance \$1,200 (-\$1000) Yes to reduction.
- Communications \$1,500 (+\$500) Yes to increase.
- Racers income \$4,000 (-\$2000) Yes to reduction.
