Finance:

Review of Budgets:

- Currently programs are allocated budgets on an annual basis and at the end of the year there is a "surplus" or deficit. Most programs view surpluses as "theirs" to carry forward.
- The question is, how do we want to view the budgets. Do we carry forward surpluses? What about deficits?
- A core belief is that Membership fees support the club and programs should be self-sustaining.
- One idea is to have programs have an "Operating" fund versus a "Special project" fund. One issue is the paid coach has a large impact on the ADP budget that the cost is attached to but the paid coach is also a club coach and contributes to other programs than solely ADP (aka racing).
- Primary principals put forward:
 - the paid coach will be considered a stand alone funding/budget item, separate from ADP (or any other program)
 - programs can have special funding or budget categories that are earmarked for future use and are carried forward and not necessarily used for annual operating funds
 - programs are held to fiscal responsibility to balance their operating budget through their inputs versus their outputs (expenses). Programs would be

held to their own financial discipline; e.g. deficit might mean higher fees of more aggressive fundraising.

- Budgets are assessed at year end and new budgets put forward for executive approval. Deficits can be run if they are rationalised to the executive and the program director gets a spanking from Steve H.
- With respect to the \$20,000 "loaned" by the racers to the Club for funding the waxhut. The ADP has run a \$3791 deficit for the 2009-10 fiscal year. The executive will cover that deficit against the \$20,000. The ADP is forecasting an approx. \$8300 deficit for the 2010-2011 season, which the Club will also cover against the balance of the \$16,200 remaining.
