- Some of tasks being covered by Communications director can be split off and passed over to a non-board member(s).
- Projects that could be addressed by interested board or non-board members include: adult ski lessons during rabbits which, in the past, helped recruit rabbit coaches; carpooling; more community engagement; more community sponsorship like credit union (pay and employees can go up to Masters)
